A surety bond therefore, is put in place to prevent the fiduciary from abusing that position of trust, such as committing fraud for example
32/22	<p>I notice from the Association of PCCs' website that you as our elected PCC set the police budget for Northumbria Police, paid from local taxation. Under a Freedom of Information request, can you provide details of the monetary amount for 2020/21; 2021/22 and 2022/23 (or appropriate timescale), plus the catchment area(s)?</p> <p>Would it also be possible for you to confirm the number of police officers with the rank of inspector and above employed by Northumbria Police.</p> <p>As you know, it appears from my research that North Tyneside Council employs over 55 senior managers costing the ratepayers at North Tyneside an estimated £2.7 million to £3.3 million per year. This appears to be an exorbitant amount of expense, particularly in view of the number of residents residing in North Tyneside, which at the last census was approximately 210,00 people.</p>	<p>As the information you have requested at this point is accessible by other means I have not provided you with a copy of the information and will rely on Section 21 of the Freedom of Information Act 2000.
