15/25	Is it a standard provision or requirement in contracts with third-party providers of relevant services (e.g. domestic abuse services, victim support), for them to use the DASH risk assessment checklist as part of their service?	There is no requirement in our grant agreement for relevant services to use DASH risk assessment as part of their service. However, the main services which are commissioned to provide domestic abuse support in Northumbria all use DASH risk assessment as standard practice.
	Is it a standard provision or requirement in contracts with third-party providers of relevant services, for them to use the DARA risk assessment checklist?	No. Northumbria Police are not yet a DARA force but are moving towards that. At present there are no plans for commissioned services to move away from the DASH RIC as the core risk checklist.
	What is the name of any current provision of domestic abuse perpetrator services you have commissioned? Which service(s) run these? What is the length of these contracts? What is the total amount awarded to these programmes?	The Northumbria Violence Reduction Unit (VRU) has been working with partners to develop a range of domestic abuse services across the Northumbria area. These include: 1. The CARA Intervention - The Northumbria VRU has been working with Northumbria Police, Hampton Trust & the Home Office to develop the CARA offer for those individuals who have been arrested for the first time for a domestic abuse related offence. 2. Make A Change (MAC) Newcastle – The Northumbria VRU has been working with Newcastle City Council, Respect & the Home Office to develop the Newcastle Domestic Abuse Perpetrator service. This service is offering the Respect MAC model for standard and medium risk perpetrators and the Northumbria Hub & Spoke Service for high risk, high harm and serial perpetrators of domestic abuse. 3. The Northumbria Hub & Spoke Model (the H&S Model) - The Northumbria VRU has been working with Northumbia Police, Local Authority partners and the Home Office to develop a 1:1 Intensive Case Management approach to high risk, high harm and serial perpetrators of domestic abuse (DA) known as the Northumbria H&S Model. This model is delivered across 6 local authority areas and by 4 service providers funded to work in a single local authority area, to attend the local MATAC panel and work alongside partner agencies in the delivery of disruption, support and

stabilisation and behaviour change interventions. The service is available regardless of sex or gender identity.

NB There is also a stalking pilot known as thew Northumbria Stalking intervention Programme (NSIP). This is a multi-agency risk management approach and does not currently include direct interventions with perpetrators. This means there is not a commissioned delivery provider. The NSIP team consists of an officer from Northumbria Police, Probation and CNTW (mental health trust) who advise referring agencies on cases of high concern. An embedded NSIP clinic applies the stalking risk profile to aid case formulation and risk management advice. The support to stalking victims within the NSIP pilot is funded by Northumbria OPCC (with a grant to Paladin).

Which service(s) run these?

- CARA This perpetrator service is delivered by Talk Listen Change.
- MAC Newcastle This perpetrator service is delivered by Harbour Prevention Services
- The H&S Model The six perpetrator services are delivered by Harbour Prevention Services (Northumberland, North Tyneside & Newcastle), Gateshead DA Team (Gateshead), Restart (South Tyneside) and Right Turn (Sunderland).

What is the length of these contracts?

- CARA The Talk Listen Change contract began in December 2023 and has recently been extended by 12 months to cover the period April 25 -March 2026. The contract for Hampton Trust began in Nov 2023 and has recently been extended by 12 months to cover the period April 25 -March 2026.
- MAC Newcastle The Harbour contract is managed by Newcastle City Council.
- The H&S Model The 6 service contracts are managed by their relevant local authority.

What is the total amount awarded to these programmes?

	 The CARA Intervention – Is funded by the Northumbria VRU and Northumbria Police. The annual cost to the VRU is £152,650 for 2025/26, including £135,250 for TLC and £17,400 awarded to Hampton Trust to license the CARA model. The additional funding needed to deliver the support of the TREAD team can be obtained from Northumbria Police. MAC Newcastle – Is funded by the Northumbria VRU, the HO and Newcastle City Council. The annual cost to the VRU (including HO funding) is £135,751 for 2025/26. The additional funding needed to deliver this service (including an Integrated Support Services for adult victims) can be confirmed by the local authority service commissioner. The Northumbria H&S model – Is funded by the Northumbria VRU, the HO and each of our 6 local authority partners. The annual cost to the VRU for the 6 services (including HO funding) is £162,390 for 2025/26. The additional funding needed to deliver these services locally (including their Integrated Support Services for victims) can be obtained from our local authority partners.
